



**Competition Entrance Affidavit & Waiver**

***The Ridge Grand Prix Tour Group, LLC***

By signing this form, I hereby agree to the 2020/2021 COVID-19 Policy and Rules for The Ridge Horse Shows. I also certify that I am following the protocols of the USEF COVID-19 Action Plan, specifically the mandatory requirements for Participants. In doing so:

- I have self-monitored my temperature daily for the last two weeks prior to entering the competition grounds and have maintained a temperature below 99.5° F (37.5° C).
- I have not exhibited COVID-19 symptoms as described by the CDC in the last two weeks.
- I have not tested positive for COVID-19 within the last two weeks.
- I have not been in contact with someone who has tested positive for COVID-19 within the last two weeks. (Exception: Healthcare personnel who have treated patients using appropriate medical-grade PPE during the course of performing professional duties are exempted from this restriction)
- I understand and agree that it is my responsibility to wear a facemask or face covering when in a public setting where there is a possibility of being within six feet of another individual, and when not mounted on a horse.
- I will self-monitor my own temperature every morning prior to leaving for the show grounds.
- If I should begin to experience any symptoms of COVID-19 or exhibit a temperature of 99.5°F (37.5°C) or above after my initial entrance onto the show grounds, I will immediately notify The Ridge at Riverview management and seek medical help.
- If I should begin to experience any symptoms of COVID-19 or exhibit a temperature of 99.5°F (37.5°C) or above within 14 days of leaving the competition, I will notify The Ridge management and immediately seek medical help.
- If I am diagnosed with COVID-19 after arriving at a competition or within 14 days of leaving the competition, I will notify management so specific steps can be made to quarantine others that may have been affected prior to that diagnosis.
- I understand that I am required to provide a valid cell phone number and email address so I will receive all notifications from the competition.

**Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19**

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people. The Ridge South, LLC and/or The Ridge Grand Prix Tour Group, LLC, have put in place preventative measures to reduce the spread of COVID-19, however, The Ridge South, LLC and/or The Ridge Grand Prix Tour Group, LLC cannot guarantee that you and/or your child(ren) will not become infected with COVID-19. As is the case with any public facility, the attendance at a horse show, even at an outdoor venue, may expose you to the COVID-19 virus. Your decision to enter the competition or attend the horse show, and access the facilities and grounds is made knowingly and voluntarily by you with full knowledge of this risk. You will be responsible for social distancing and any other safety precautions. Further, attending the horse show could increase your risk and/or your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending a horse show and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at a horse show may result from the actions, omissions, or negligence of myself and others, including, but not limited to The Ridge South, LLC, The Ridge Grand Prix Tour Group, LLC, it's employees, volunteers, and program participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself, including, but not limited to: personal injury, disability and death, illness, damage, loss, claim, liability, or expense of any kind that I or my child(ren) may experience or incur in connection with my child(ren)'s or my own attendance at or participation in The Ridge South, LLC and/or The Ridge Grand Prix Tour Group, LLC horse shows. On my behalf and on behalf of my child(ren), I hereby release, convent not to sue, discharge, and hold harmless claims, actions, damages, costs or expenses of any kind arising our of or relating thereto. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of The Ridge South, LLC and The Ridge Grand Prix Tour Group, LLC, it's employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any event run by The Ridge South, LLC and/or The Ridge Grand Prix Tour Group, LLC.

If you choose to enter the showgrounds, you assume the risk for your possible exposure to COVID-19. If you disagree, please do not enter the showgrounds. Entrance to the showgrounds will constitute a waiver and release of The Ridge South, LLC and/or The Ridge Grand Prix Tour Group, LLC and any of its affiliates from any and all liability with respect to exposure to the COVID-19 virus.
